## Undergraduate Admission, Spring 2025 Notice for verification of FF & RA Quota, English Medium (O & A Level) and Name Mismatch Correction Candidates

The applicants who applied for admission through FF quota, RA quota, and English Medium (O-Level and A-Level) need to prove their eligibility to the Verification Committee on 05 October, 2025 (Sunday) and need to be present at the M. H. Khan Auditorium, AUST with the following documents. The verification will commence from 10:00 AM until 3:30 PM on the above date.

- FF quota candidates must bring their parent's (i.e. father or mother) Freedom Fighter certificate
  at the time of appearing before the Verification Committee of AUST (From 10:00 AM to 11:30
  AM).
- RA quota candidates must bring copies of testimonials from their school and/or college and residency certificates from the local UNO or DC when appearing before the Verification Committee of AUST (From 12:00 PM to 3:30 PM).
- English Medium (O-Level and A-Level) candidates must bring copies of certificates and grade sheets of their O-Level and A-Level examinations issued by an appropriate authority like Cambridge, Pearson Edexcel, etc. at the time of appearing before the Verification Committee of AUST (From 10:00 AM to 11:30 AM).

## Name Mismatch:

Those candidates who failed to show relevant documents earlier must bring the necessary documents when appearing before the Verification Committee of AUST at the VC Seminar Room from 10:00 AM - 3:30 PM on 05 October 2025.
